This quadruple 2-input positive-OR gate is operational at 0.8-V to 2.7-V  $V_{CC}$ , but is designed specifically for 1.65-V to 1.95-V  $V_{CC}$  operation.

The SN74AUC32 device performs the Boolean function Y = A + B or  $Y = \overline{A} \cdot \overline{B}$  in positive logic.

This device is fully specified for partial-power-down applications using I<sub>off</sub>. The I<sub>off</sub> circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.





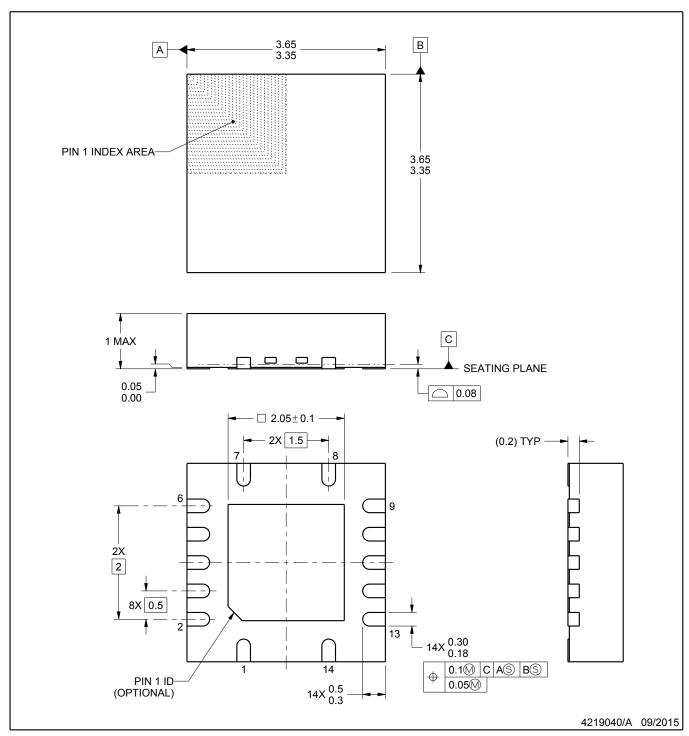

PLASTIC QUAD FLATPACK - NO LEAD

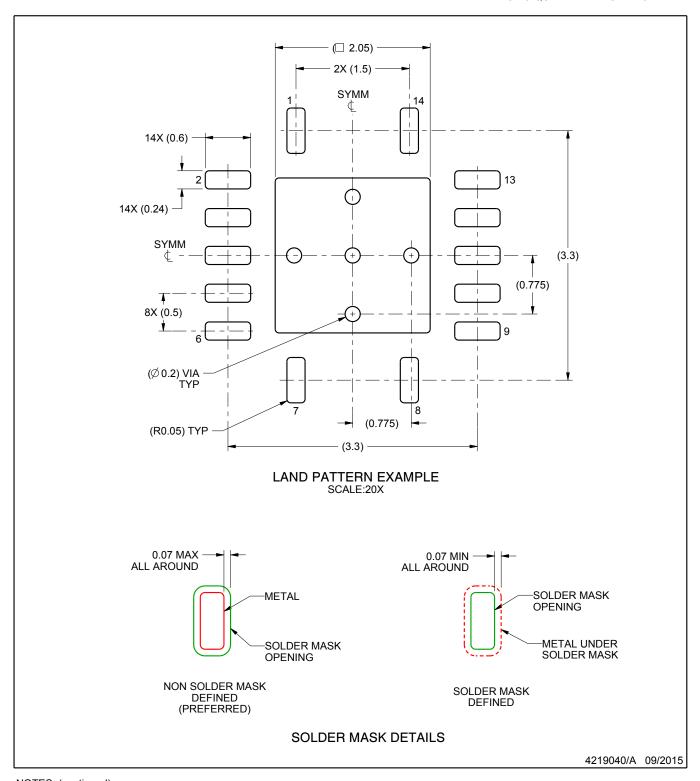

PLASTIC QUAD FLATPACK - NO LEAD

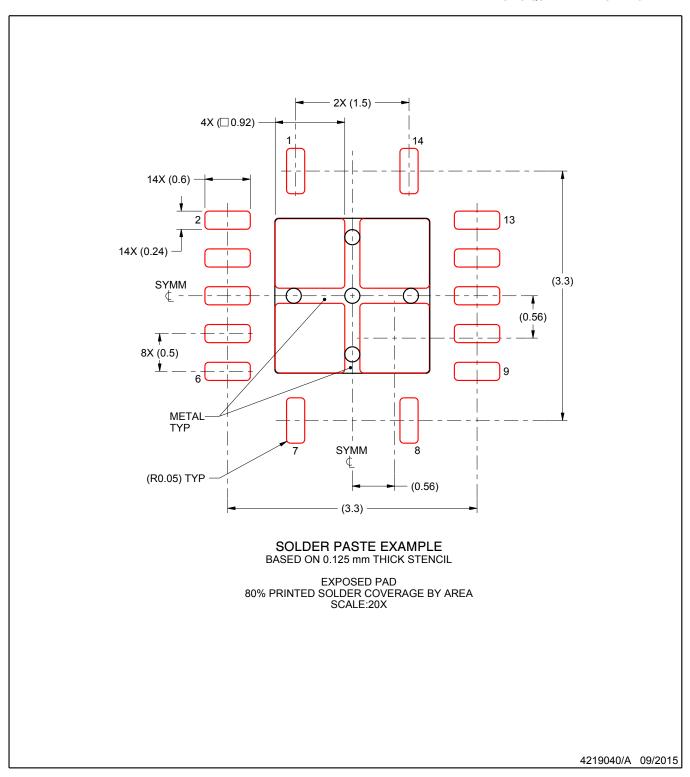
