

EVM User's Guide: TPSM82813PEVM-062, TPSM82816PEVM-062 MagPack™ Technology 3A/6A Power Module with Frequency Sync Evaluation Module

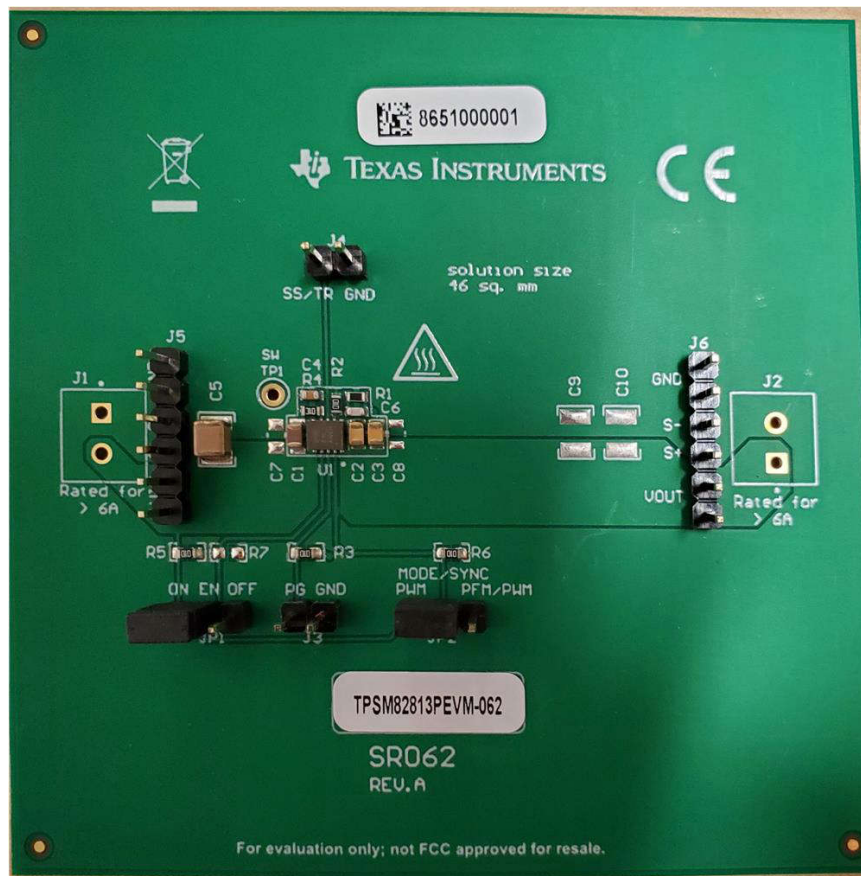


Description

The TPSM8281xPEVM-062 evaluation modules (EVM) facilitate the evaluation of the TPSM82813 and TPSM82816, 3A and 6A pin-to-pin compatible step-down power modules with frequency synchronization in a 2.5mm × 3mm × 1.95mm MagPack™ package. The EVMs provide a 1.8V output voltage with 1% accuracy for input voltages up to 6V.

Features

- 6A or 3A output current power module with integrated inductor in a MagPack™ package
- 2.5mm × 3mm power module provides 46mm² total solution-size with 1.95mm height
- Excellent thermal performance ($\theta_{JA} = 26.6 \text{ }^\circ\text{C/W}$ for TPSM82816 and $27.4 \text{ }^\circ\text{C/W}$ for TPSM82813)
- Synchronizable to an external clock



1 Evaluation Module Overview

1.1 Introduction

The TPSM8281x EVMs enables evaluation of the TPSM8281x power module in a typical, step-down converter application. The TPSM8281x is a high-efficiency, high-accuracy and small point-of-load (POL) power design in applications such as optical modules, signal measurement, patient monitoring, wireless infrastructure, ruggedized communication, and other space-limited applications.

1.2 Kit Contents

The TPSM8281xPEVM-062 EVM box (the kit) includes a PCB (SR062) with which to evaluate the TPSM8281x device in a typical application.

1.4 Device Information

The TPSM8281x is a family of pin-to-pin compatible 1A to 6A power modules, which integrate the inductor.

3 Implementation Results

The TPSM8281xPEVM-062 was used to take all the data in the [TPSM8281x 2.7V to 6V Input 4A / 6A Step-Down Power Module with Integrated Inductor, Frequency Synchronization in MicroSiP™ and MagPack™ Package](#) data sheet and [TPSM8281x 2.75V to 6V Input 4A and 3A Step-Down Power Module with Integrated Inductor and Frequency Synchronization in MicroSiP™ and MagPack™ Package](#) data sheet. See the device data sheets for the performance of these EVMs.

3.1 Performance Data and Results

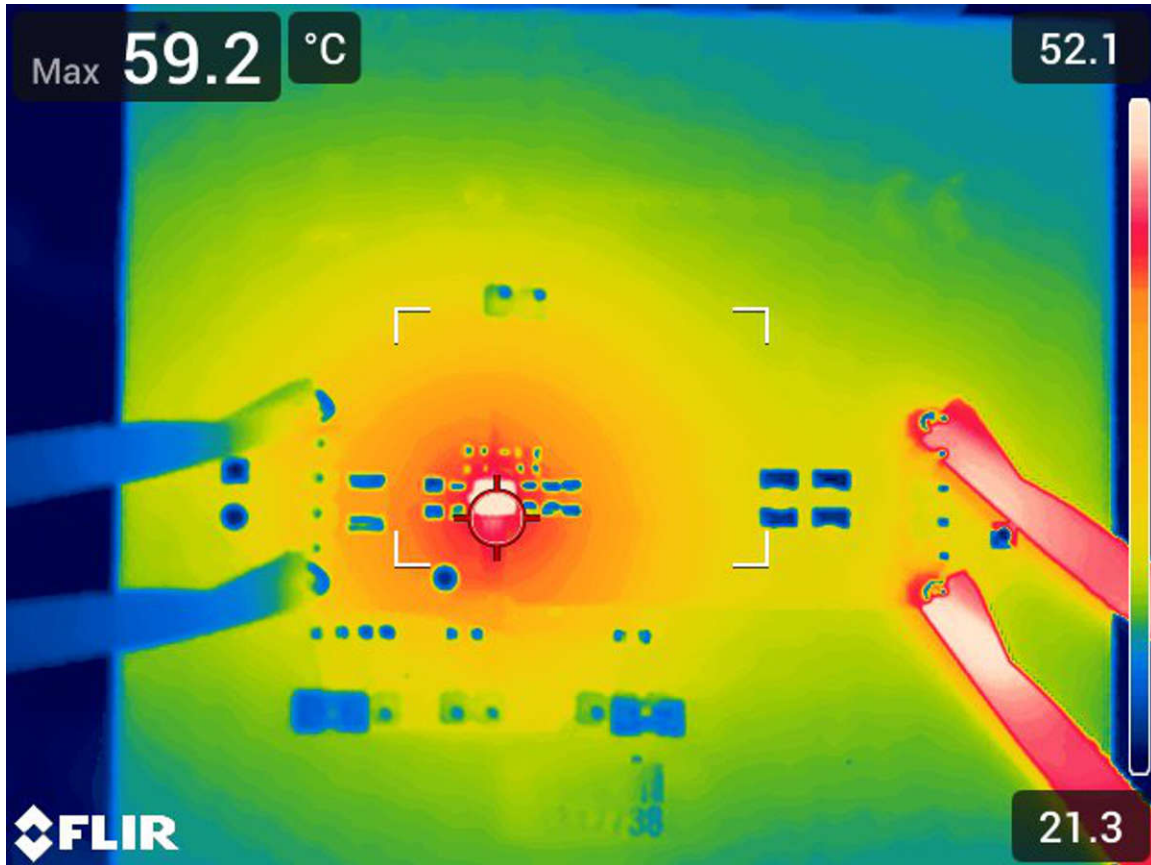


Figure 3-1. Thermal Performance (TPSM82816PEVM-062, $V_{IN} = 5V$, $V_{OUT} = 1.8V$, $I_{OUT} = 6A$)

Figure 3-1 shows the thermal performance of the TPSM82816PEVM-062.

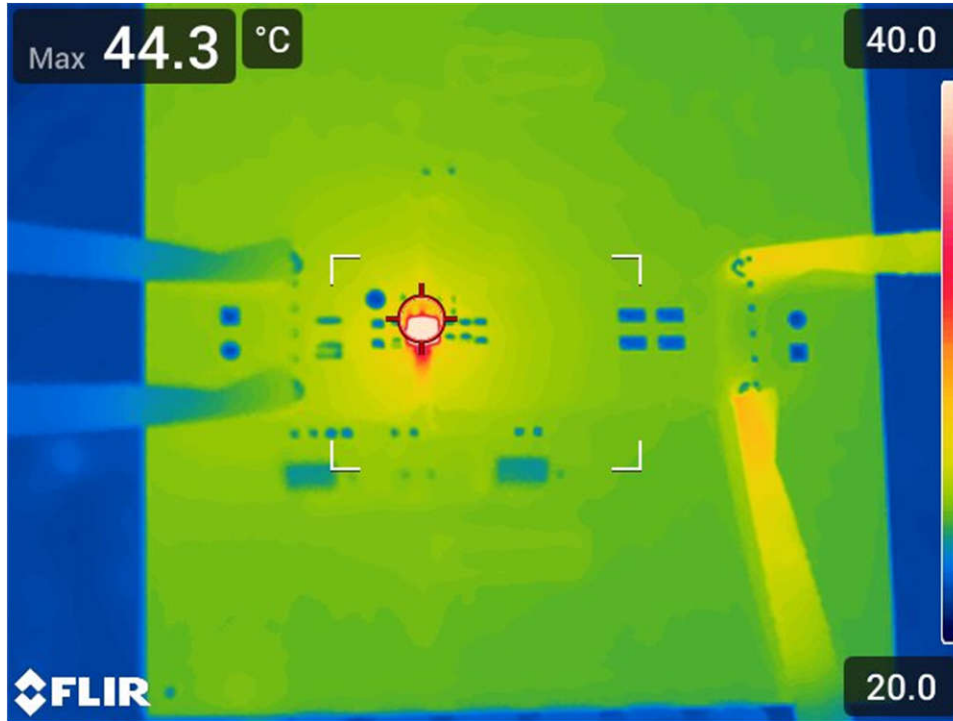


Figure 3-2. Thermal Performance (TPSM82813PEVM-062, $V_{IN} = 5V$, $V_{OUT} = 1.8V$, $I_{OUT} = 3A$)

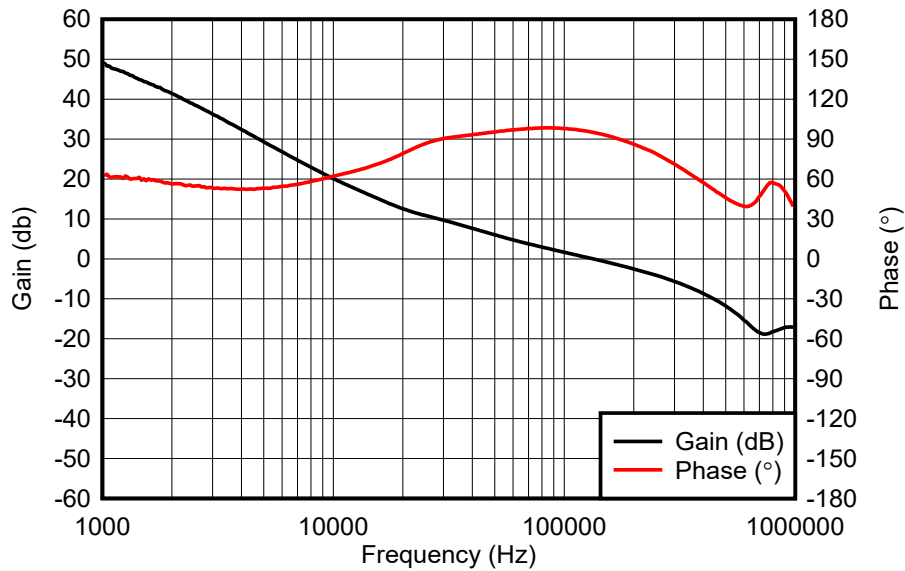


Figure 3-3. Loop Response Measurement (TPSM82816PEVM-062, $V_{IN} = 5V$, $V_{OUT} = 1.8V$, $I_{OUT} = 6A$)

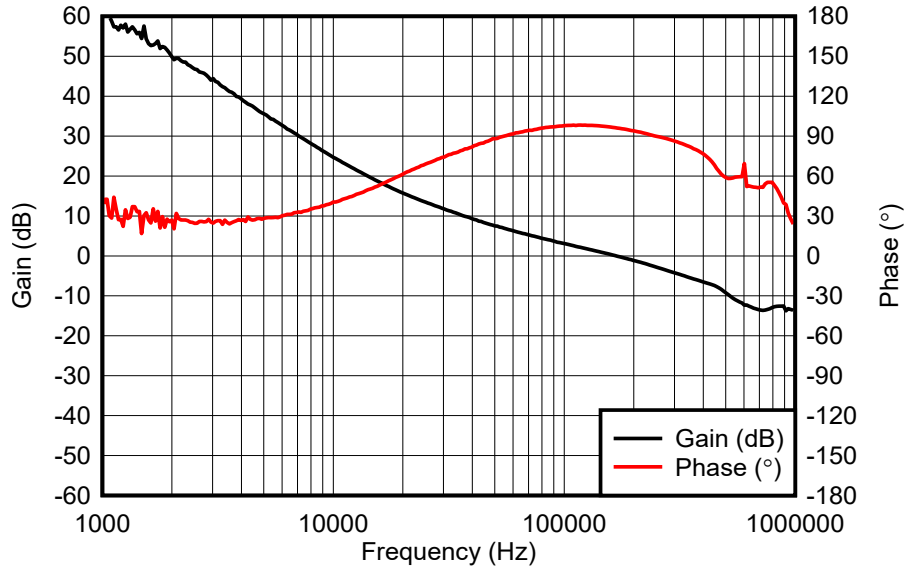


Figure 3-4. Loop Response Measurement (TPSM82813PEVM-062, $V_{IN} = 5V$, $V_{OUT} = 1.8V$, $I_{OUT} = 3A$)

3.2 Modifications

The printed-circuit board (PCB) for this EVM is designed to accommodate some modifications by the user. Additional input and output capacitors can be added. Also, the switching frequency, spread spectrum, control loop compensation, and soft-start time can be changed. Finally, the loop response can be measured and a precise turn-on voltage can be implemented.

3.2.1 Input and Output Capacitors

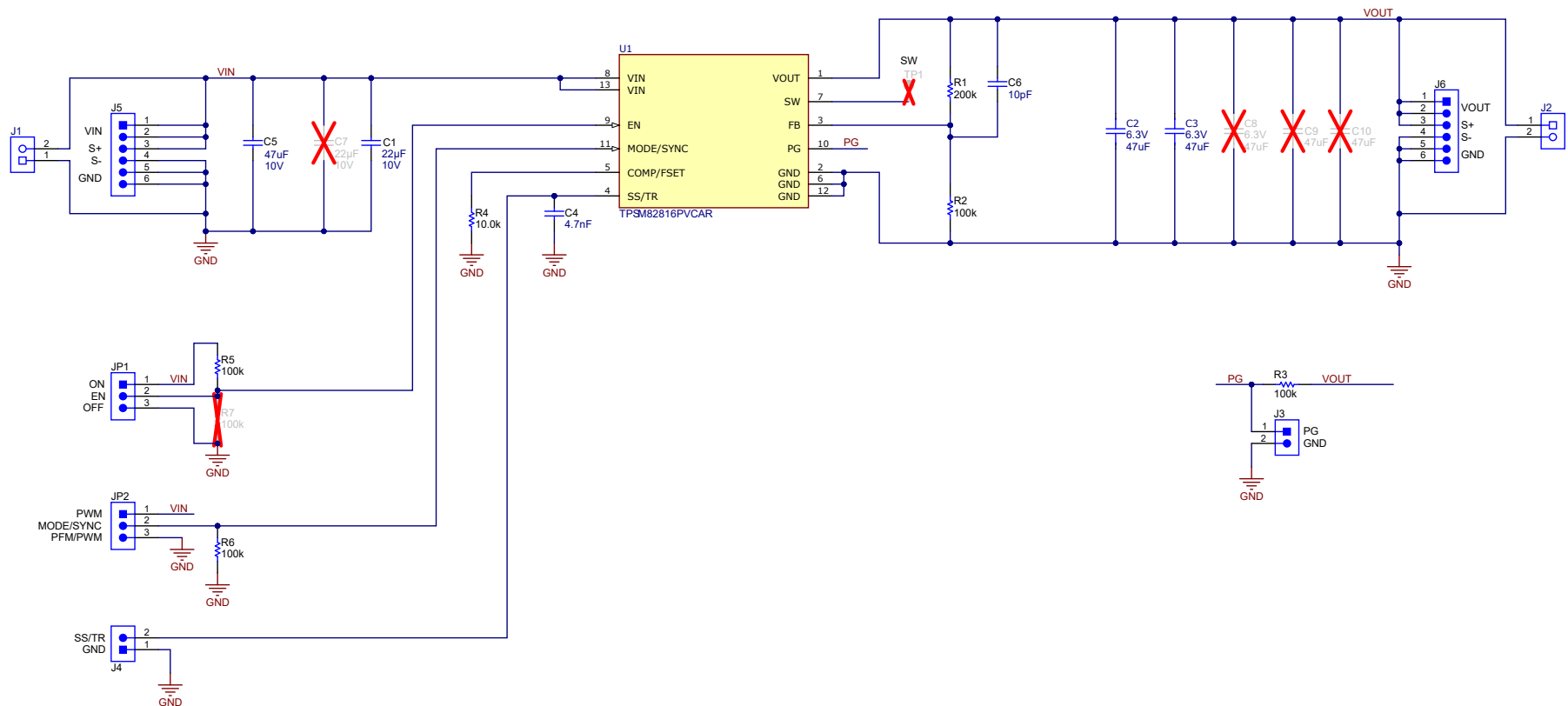


Figure 4-1. TPSM8281xPEVM-062 Schematic

C7, shown in Figure 4-1, is provided for an additional input capacitor. This capacitor is not required for proper operation, but can be used to reduce the input voltage ripple.

C8, C9, and C10 are provided for additional output capacitors. These capacitors are not required for proper operation but can be used to reduce the output voltage ripple and to improve the load transient response. The total output capacitance must remain within the recommended range in the data sheet for proper operation.

C8 must be populated with a 47 μ F capacitor to improve the load regulation and transient response for output voltages below 1V.

3.2.2 Switching Frequency, Spread Spectrum and Control Loop Compensation

R4 sets the switching frequency and control loop compensation setting of the converter. On the TPSM82816 device only, the R4 also enables or disables spread spectrum. See the data sheet for details.

3.2.3 Soft-Start Time

C4 controls the soft-start time of the output voltage. C4 can be changed for a faster or slower ramp-up of the output voltage. Note that the soft-start time is different (with the same C4 value) for the TPSM82813 and TPSM82816.

3.2.4 Loop Response Measurement

The loop response can be measured by adding a 50 Ω resistor between VOUT and R1/C6. Figure 3-3 and Figure 3-4 show the results of this test.

3.2.5 Precise Turn-on Voltage

With the jumper on JP1 removed, R5 and R7 can be modified to create a precise turn-on voltage. See [Achieving a Clean Start-up by Using a DC/DC Converter with a Precise Enable-pin Threshold technical brief](#) for details.

4 Hardware Design Files

4.1 Schematic

Figure 4-1 shows the EVM schematic. The TPSM82813PEVM-062 uses the TPSM82813PV CAR IC. The TPSM82816PEVM-062 uses the TPSM82816PV CAR IC.

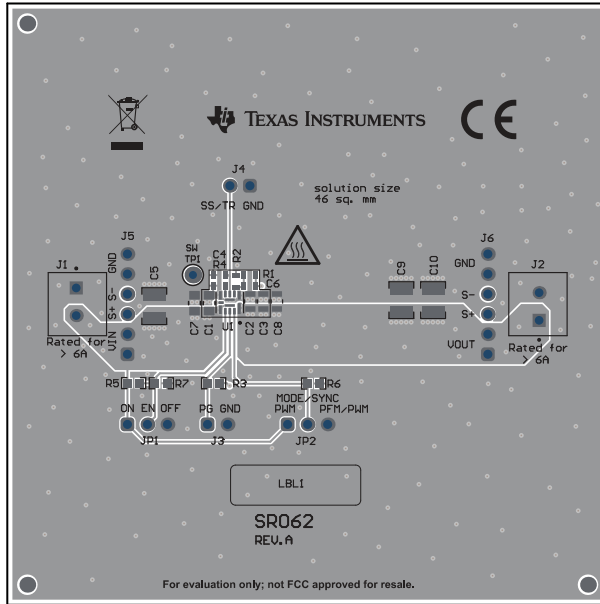


Figure 4-2. Top Assembly

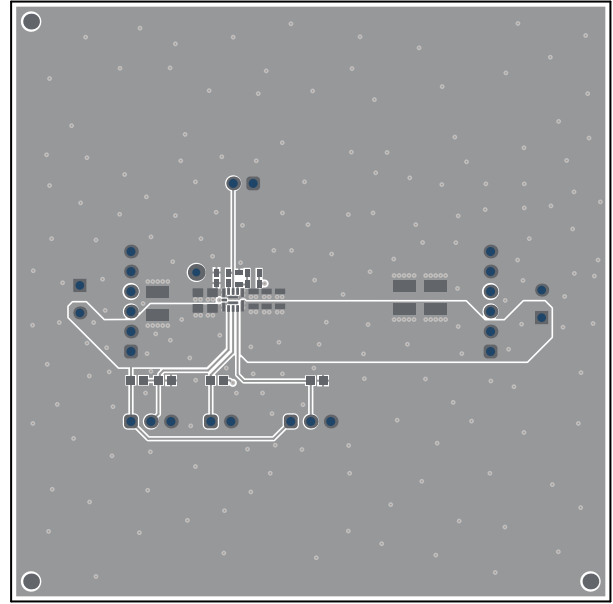


Figure 4-3. Top Layer

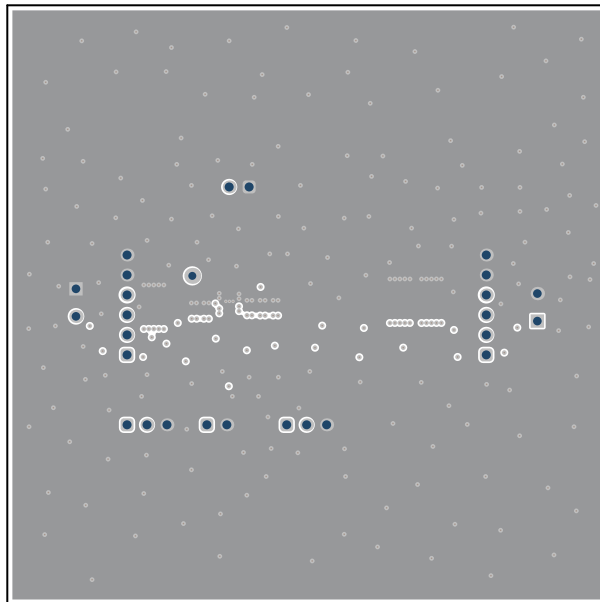


Figure 4-4. Internal Layer 1

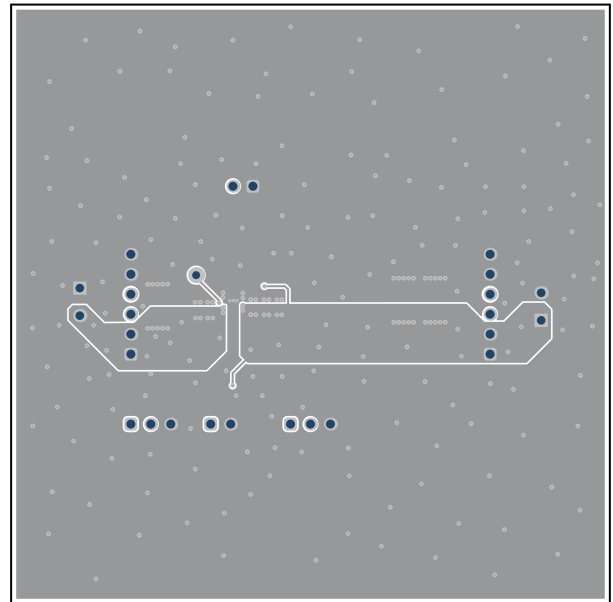


Figure 4-5. Internal Layer 2

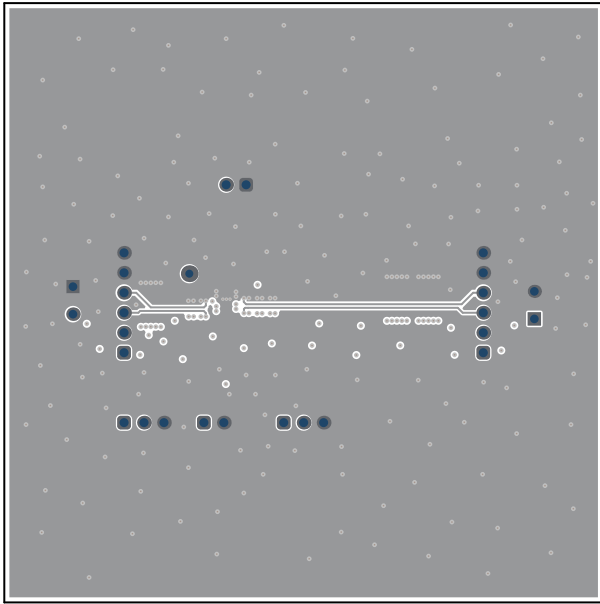


Figure 4-6. Bottom Layer

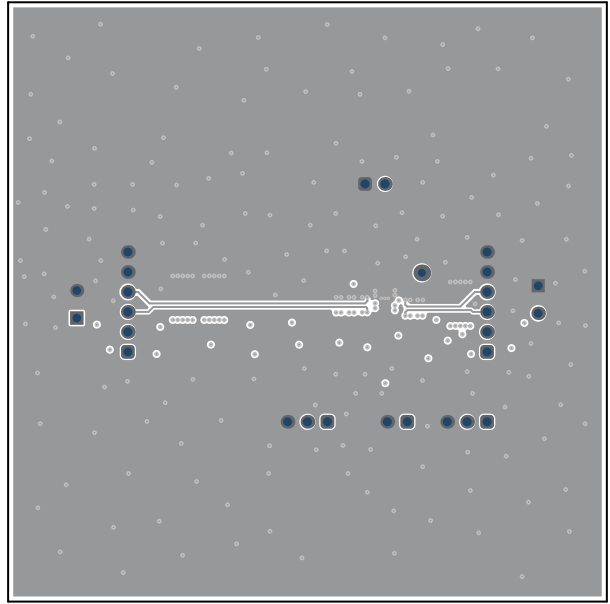


Figure 4-7. Bottom Layer (Mirrored)
