

# LM74900Q1EVM Evaluation Module for LM749x0-Q1 Ideal Diode Controller



## ABSTRACT

This user's guide describes the LM74900Q1EVM evaluation module for evaluating the performance of the LM749x0-Q1 ideal diode controller devices. The LM749x0-Q1 ideal diode controller drives and controls external back to back N-Channel MOSFETs to emulate an ideal diode rectifier with power path ON/OFF control, as well as overcurrent, short-circuit, and overvoltage protection. This document provides EVM configuration information and test setup details for evaluating the LM749x0-Q1 device. The EVM schematic, board layout, and bill of materials (BOM) are also included.

## 1 Introduction

TI's LM749x0-Q1 evaluation module LM74900Q1EVM helps designers evaluate the operation and performance of the LM74900-Q1 and LM74910-Q1 ideal diode controllers with power path ON/OFF control, overcurrent, short-circuit and overvoltage protection. The wide input supply of LM749x0-Q1, 3 V to 65 V, allows protection and control of 12-V and 24-V automotive battery powered ECUs. The LM749x0-Q1 device can withstand and protect the loads from negative supply voltages down to -65 V. An integrated ideal diode controller (DGATE) drives the first MOSFET to replace a Schottky diode for reverse input protection and output voltage holdup. With a second MOSFET in the power path the device allows load disconnect (ON/OFF control) in case of overcurrent and overvoltage events using HGATE control.

### 1.1 EVM Features

Key LM74900Q1EVM features include:

- 3-V to 65-V input range
- 5-A to 10-A adjustable overcurrent protection using on-board jumpers
- Programmable circuit breaker timer
- Load current monitoring output
- Programmable auto-retry and latch options
- LED for fault indication
- LED indication for output ON/OFF detection
- LM74910-Q1 default device

### 1.2 EVM Applications

This EVM can be used for the following applications:

- Automotive reverse battery protection
- ADAS domain controller
- Camera, radar ECUs
- Head unit
- Premium audio amplifier

## 2 Description

The LM74900Q1EVM is configured by default for evaluating 12-V automotive reverse battery protection with switched output to disconnect power path or clamp the output. The EVM can be used to evaluate both LM74900-Q1 and LM74910-Q1 devices.

By default the LM74900Q1EVM has LM74910-Q1 (U1) device populated for evaluation. For evaluation of LM74900-Q1, the user needs to replace U1 with LM74900-Q1.




Figure 3-1. LM7490Q1EVM: Evaluation Module Schematic

## 4 General Configurations

### 4.1 Physical Access

Table 4-1 lists the LM74900Q1EVM evaluation board input and output connector functionality. Table 4-2 and Table 4-3 describe the test point availability and the jumper functionality.

## 4.2 Test Equipment and Setup

### 4.2.1 Power Supplies

One adjustable power supply with 0-V to 60-V output and 0-A to 50-A output current limit.

### 4.2.2 Meters

One DMM minimum needed.

### 4.2.3 Oscilloscope

A DPO2024 or equivalent, 3 × 10 voltage probes, and a DC current probe.

### 4.2.4 Loads


One resistive load or equivalent that can tolerate up to 50-A DC load at 60 V and capable of the output short.

## 5 Test Setup and Procedures

Make sure the evaluation board has default jumper settings as shown in [Table 5-1](#).

Use the following instructions before starting any test and repeat again before moving to next test.

1. Set the power supply output VIN to 0 V.
2. Turn ON the power supply and set the power supply output VIN to 12 V and current limit of 10 A.
3. Turn OFF the power supply.
4. Set the jumper setting on EVM to default position as shown in [Table 5-1](#).

## 5.1 Power-Up and Power-Down With EN Control

Use the following instructions to capture the precharging current profile.

1. Initially connect the EN pin to GND by setting J5 jumper at 2-3 position.
2. Set the input supply voltage VIN to 12 V and current limit of 10 A.
3. Turn ON the power supply.
4. Enable the LM74900-Q1 device by connecting EN pin to C. Change the J5 jumper setting to 1-2.
5. Observe the start-up profile of charge pump voltage ( $V_{CAP} - V_{VS}$ ), output voltage, HGATE, and DGATE.
6. Disable the LM74900-Q1 device by connecting EN pin to GND. Change the J5 jumper setting to 2-3.
7. Observe the shutdown profile of charge pump voltage ( $V_{CAP} - V_{VS}$ ), output voltage, HGATE, and DGATE.




Figure 5-2. LM74900-Q1 Start-Up With EN - Output Voltage and Input Current Profile

Figure 5-2 shows an example of power-up with EN profile captured on the LM74900Q1EVM evaluation board.




Figure 5-3. LM74900-Q1 Start-Up With EN - Charge Pump and Output Voltage Profile




Figure 5-4. LM74900-Q1 Shutdown With EN - HGATE and Output Voltage Profile




Figure 5-5. LM74900-Q1 Shutdown With EN - DGATE and Output Voltage Profile

## 5.2 Input Overvoltage Test

Use the following instructions to verify the overvoltage protection feature of LM74900-Q1.

1. Remove the input 33-V TVS (D1) in case you want to set and test the input overvoltage threshold, which is greater than the breakdown voltage (40 V) of the TVS.
2. Set the input supply voltage VIN to 12 V and current limit of 10 A.
3. Turn ON the power supply and observe start-up of output voltage, HGATE, and DGATE.
4. Slowly increase the input voltage to 40 V. Observe the HGATE going low and turn OFF the load switch FETs (Q2 and Q4) when the input voltage reaches overvoltage protection threshold of 37 V.




Figure 5-6. Overvoltage Protection

### 5.3 Overcurrent Protection Test

Use the following instructions to perform the overcurrent test on the LM74900Q1EVM.

1. Set the input supply voltage  $V_{IN}$  to 12 V and current limit of 10 A.
2. Turn ON the power supply and observe start-up of output voltage, HGATE, and DGATE.
3. By default the EVM is configured for 5-A overcurrent protection.
4. Apply 4-A load at the output with rheostat or electronic load and gradually increase the load current to 6 A.
5. Observe the overload behavior of LM74900-Q1.




Figure 5-7. Overcurrent Response of LM74900-Q1 for a Load Step From 4 A to 6 A With 5-A Overcurrent Protection Setting




Figure 5-8. Auto-Retry Response of LM74900-Q1 for an Overcurrent Fault

Figure 5-7 and Figure 5-8 show test waveforms for an overcurrent fault.

## 5.4 Output Hot-Short Test

Use the following instructions to perform output the hot-short test.

1. Set the input supply voltage  $V_{IN}$  to 12 V and current limit of 10 A.
2. Turn ON the power supply and observe start-up of output voltage, HGATE, and DGATE.
3. Short the output to GND. That is,  $V_{OUT}$  to GND with a cable and observe the short-circuit response of LM74900-Q1 using an oscilloscope.





Figure 5-9. Output Hot-Short Response of LM74900-Q1 Device

Figure 5-9 shows hot-short response of LM74900-Q1 on LM74900Q1EVM evaluation board.




Figure 6-5. LM74900Q1EVM Board Inner Layer 1




Figure 6-6. LM74900Q1EVM Board Inner Layer 2
