



- ZZ1 ■ Install label in silkscreened box after final wash. Text shall be 8 pt font. Text shall be per the Label Table in the PDF schematic.
- ZZ5 ■ Tape Coil, RX into bottom of case, CENTERED, coil side down, lead wires passing through milled groove
- ZZ6 ■ Install PCB in Case using #4 x 3/8 screws, inserting 0.1 thick spacers between PCB and case
- ZZ7 ■ The value of R2 + R6 can be adjusted to 250-ohms for WPC 1.1 requirements (FOD calibration only for this EUM)
- ZZ2 ■ These assemblies are ESD sensitive, ESD precautions shall be observed.
- ZZ3 ■ These assemblies must be clean and free from flux and all contaminants. Use of no clean flux is not acceptable.
- ZZ4 ■ These assemblies must comply with workmanship standards IPC-A-610 Class 2., unless otherwise specified.
