

# COVID-19 **Supplier Expectations**

**Updated June 1, 2022**

No longer requiring U.S. visitors and suppliers to show proof of vaccination or a negative test to come on site; protocols outlined on slide 2.

# TI COVID-19 safety protocols

**June 2022 update:** Visitors (including suppliers) are **not required** to show proof of vaccination or a negative test to come on site at this time. Suppliers can manage their employees' vaccination and exemption status at their discretion.

## Quarantine and mask protocols for positive cases or close contacts

Test positive (symptomatic or asymptomatic) or displaying COVID symptoms	<p><b>DO NOT</b> send the employee to work on a TI site <b>DO</b> let your TI host, sponsor or WPL contact know.</p> <p><b>Positive test with symptoms or displaying COVID-19 symptoms without a positive test:</b> quarantine for 5 days from the date of the onset of symptoms.</p> <p>After 5 days, if symptoms are improving, and employee has no fever within last 24 hours, it's ok to return to TI site but they must wear mask for an additional 5 days.</p> <p><b>Positive test with no symptoms:</b> quarantine for 5 days from positive test result, then it's ok to return to TI site but must wear a mask for an additional 5 days.</p>
Known close contact with someone with COVID-19	No quarantine is required, but you must wear a mask for 10 days <b>or</b> remove mask if you receive a negative test 5 or more days after exposure
Masking	While onsite, wearing a mask while indoors at TI sites is optional. Masks cannot have an exhalation valve.
Travel	No quarantine required for anyone post-travel.

**Not following TI safety protocols will impact your ability to work onsite at TI.**

# If you have a confirmed COVID-19 case (page 1 of 2)

## Ask the following questions:

1. To the best of your recollection, from two days before your symptoms began (or, if asymptomatic, two days before you were tested for COVID-19) until now, did you have “close contact” with anyone at TI? *Note: “Close Contact” is defined as being within six feet of another person for at least 15 consecutive minutes if the contact occurred in the cleanroom or at least 15 cumulative minutes within 24 hours if the contact occurred outside the cleanroom.*

- Who?
- When?
- Where?

2. Have you been wearing a facial covering while at work?

3. How/when do you believe you contracted COVID-19?

4. Have you engaged in any non-work-related activities that may have exposed you to someone who has COVID-19 (e.g., activities involving close contact with others outside of your household)? [yes or no answer only – do not ask further questions]

5. Have you had close contact outside of the workplace with someone who has a confirmed case of COVID-19? [yes or no only]

- **If no**, no further questions
- **If yes**, was the contact work-related?
- **If no**, no further questions
- **If yes**, ask for details

# If you have a confirmed COVID-19 case (page 2 of 2)

## Ask the following questions:

6. Do you live in the same household as anyone who works at TI (employee, contractor, vendor)? Who?
7. Do you consent to share your name and confirmed status with the TI workers with whom you've had close contact or do you want to remain anonymous?
8. From two days before your symptoms began (or, if asymptomatic, two days before you were tested for COVID-19) until now, what TI buildings and locations did you visit? (e.g. cafeteria, area of fab, conference room)?
9. To the best of your recollection, please tell me each room and location within TI that you visited from two days before your symptoms began (or, if asymptomatic, two days before you were tested for COVID-19) until now? Please check your calendar if it will help jog your memory.
  - In which part of the building do you spend the majority of your time?
  - Where do you take your breaks?
  - How do you get to/from work? If you drive, do you drive alone?
  - Where do you park?
  - Which entrance do you use?
