

# TPS563252 and TPS563257 Step-Down Converter Evaluation Module User's Guide



## ABSTRACT

This user's guide introduces the TPS563252EVM and TPS563257EVM. These two devices differ in their light load behavior. The TPS563252 operates in Eco-mode and the TPS563257 operates in FCCM mode. This user's guide contains information for the TPS563252 and TPS563257 as well as support documentation for the TPS563252EVM and TPS563257EVM evaluation modules. This document also includes the following information for the TPS563252EVM and TPS563257EVM:

## 1 Introduction

In light-load conditions, the TPS563252 operates in Eco-mode to enable higher efficiency by varying its switching frequency, and the TPS563257 operates in FCCM to maintain constant switching frequency. The main difference is at light loading, but the other behaviors are similar. This user's guide mainly introduces the TPS563252 and includes some TPS563257 features that are different from the TPS563252.

The TPS56325x is a single, adaptive on-time, D-CAP3™ control mode, synchronous buck converter that requires a very low external component count. The D-CAP3 control mode circuit is optimized for low-ESR output capacitors such as POSCAP, SP-CAP, or ceramic types and features fast transient response with no external compensation. The switching frequency is internally set at a nominal 1.2 MHz. The high-side and low-side switching MOSFETs are incorporated inside the TPS56325x package along with the gate-drive circuitry. The low drain-to-source on resistance of the MOSFETs and fast switching slew rate allow the TPS56325x to achieve high efficiency and help keep the junction temperature low at high output currents. Power sequencing is possible by correctly configuring the enable and power-good indicator. The TPS56325x DC/DC synchronous converter is designed to support up to a 3-A continuous current from an input voltage source of 3 V to 17 V. The output voltage range is from 0.6 V to 10 V. Rated input voltage and output current ranges for the evaluation module are given in [Table 1-1](#).

The TPS563252EVM evaluation module (EVM) is a single, synchronous buck converter providing 1.05 V at 3 A from 3-V to 17-V input. This user's guide describes the TPS563252EVM performance.

## 2 Performance Specification Summary

A summary of the TPS563252EVM performance specifications is provided in [Table 2-1](#). Specifications are given for an input voltage of  $V_{IN} = 12\text{ V}$  and an output voltage of  $1.05\text{ V}$ , unless otherwise noted. The ambient temperature is  $25^{\circ}\text{C}$  for all measurement, unless otherwise noted.

## 3 Output Voltage Setpoint

The output voltage of the EVM can be selected by changing the value of resistor  $R_4$  ( $R_{FBT}$ ) and  $R_5$  ( $R_{FBB}$ ). TI recommends using 1% tolerance or better divider resistors. Start with a  $10\text{ k}\Omega$  for  $R_5$  ( $R_{FBB}$ ) and use [Equation 1](#) to calculate  $R_4$  ( $R_{FBT}$ ). To improve efficiency at light loads, consider using larger value resistors. If the values are too high, the regulator is more susceptible to noise and voltage errors from the FB input current are noticeable.

$$R_4 = \frac{R_5 \times (V_{out} - 0.6\text{ V})}{0.6\text{ V}} \quad (1)$$

## 4 Test Setup and Results

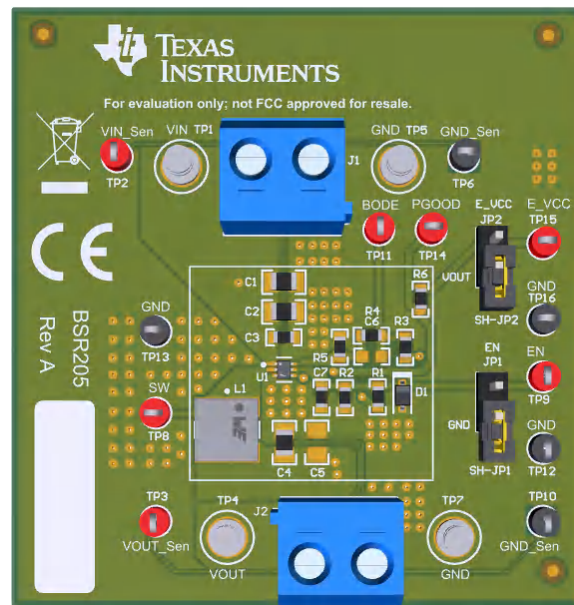
This section describes how to properly connect, set up, and use the TPS563252EVM. The section also includes test results typical for the evaluation modules and the following:

- Efficiency
- Output load regulation
- Output line regulation
- Load transient response
- Start-up
- Shutdown
- Output voltage ripple

### 4.1 Input and Output Connections

The TPS563252EVM is provided with input and output connectors and test points as shown in [Table 4-1](#). [Figure 4-1](#) shows connectors and jumpers placement on the TPS563252EVM board.

A power supply capable of supplying  $3\text{ A}$  must be connected to J1 through a pair of 20-AWG wires. The load must be connected to J2 through a pair of 20-AWG wires. The maximum load current capability is  $3\text{ A}$ . Wire lengths must be minimized to reduce losses in the wires. Test point TP2 provides a place to monitor the  $V_{IN}$  input voltages with TP6 providing a convenient ground reference. TP3 is used to monitor the output voltage with TP10 as the ground reference.

## 4.2 Start-Up Procedure

1. Ensure that the jumper at JP1 (Enable control) pins 1 and 2 are covered to shunt EN to GND, disabling the output.
2. Apply appropriate input voltage to  $V_{IN}$  (J1-2) and GND (J1-1).
3. Move the jumper at JP1 (Enable control) pin 2 and 1 (EN and GND) to enable the output.

### 4.3 Efficiency

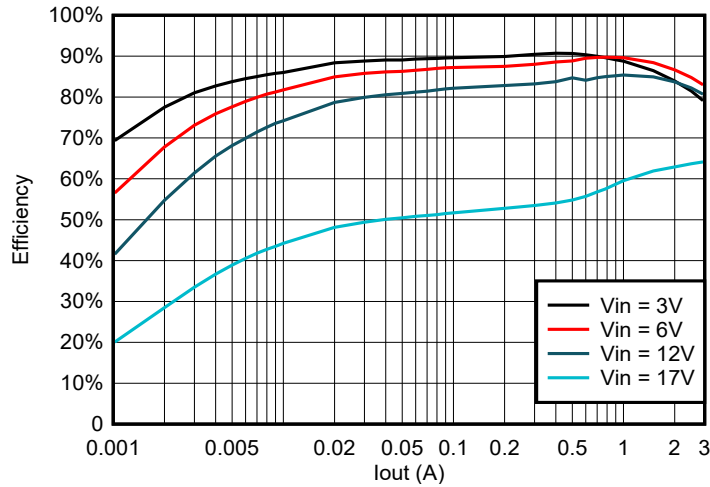


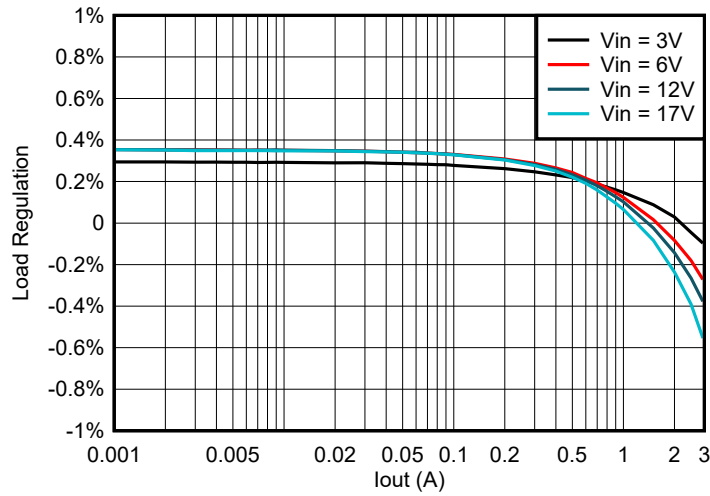
Figure 4-2. TPS563252EVM Efficiency



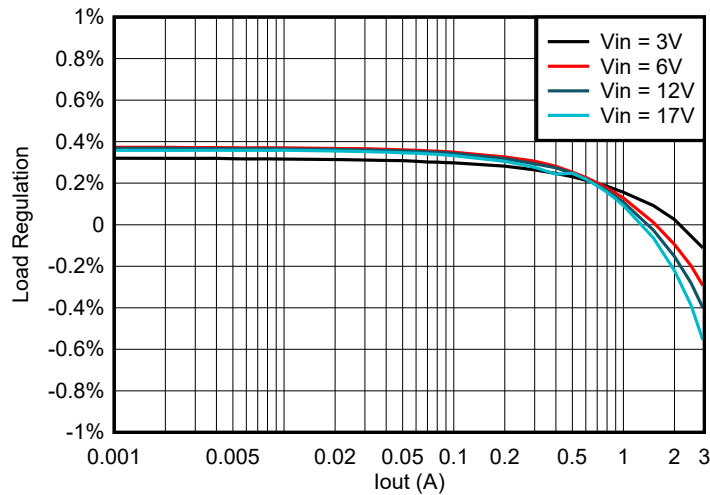
Figure 4-3. TPS563257EVM Efficiency

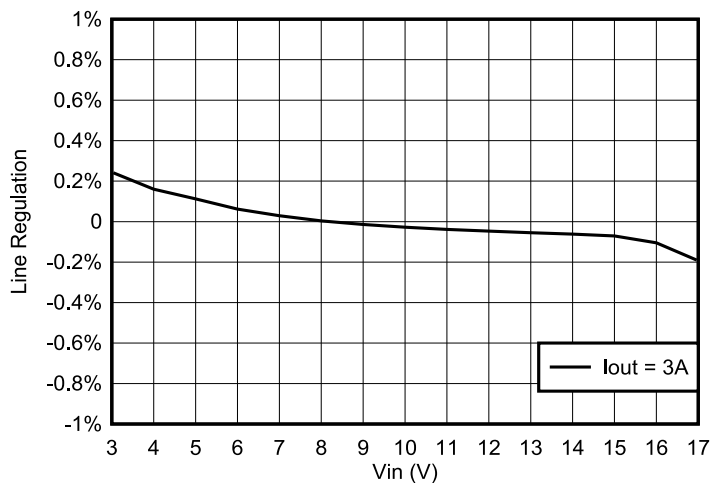
**Figure 4-4. TPS563252EVM Load Regulation**



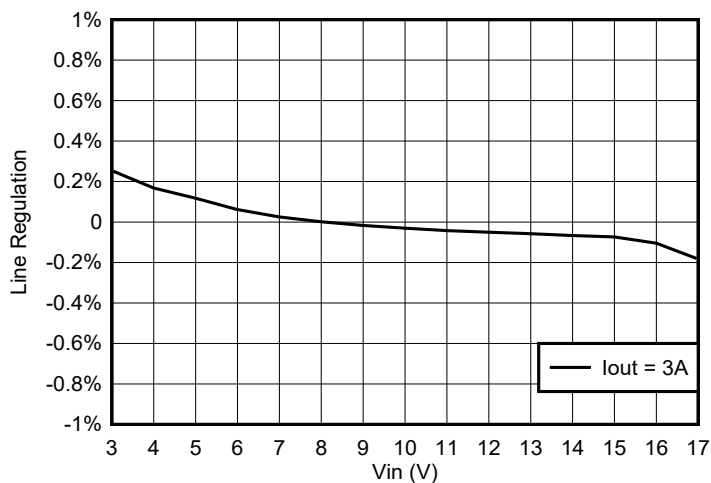
**Figure 4-5. TPS563257EVM Load Regulation**

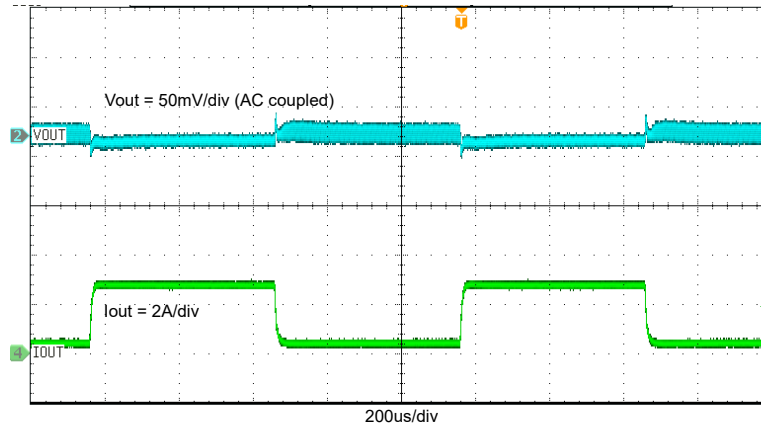


Figure 4-8. TPS563252EVM Load Transient Response, 10% to 90% (0.3 A to 2.7 A) Load Step

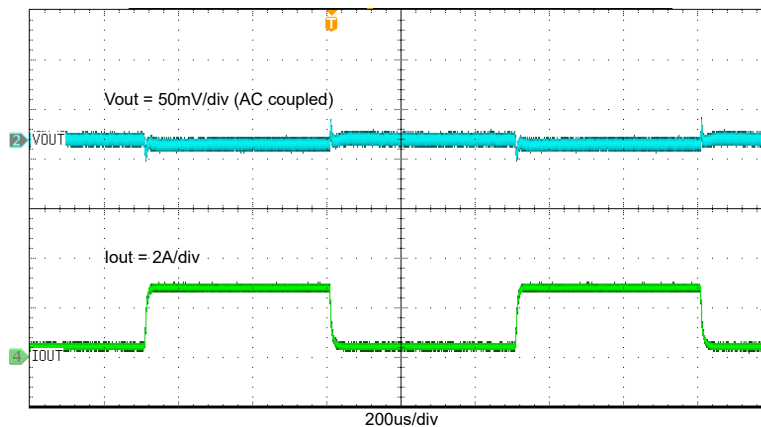


Figure 4-9. TPS563257EVM Load Transient Response, 10% to 90% (0.3 A to 2.7 A) Load Step

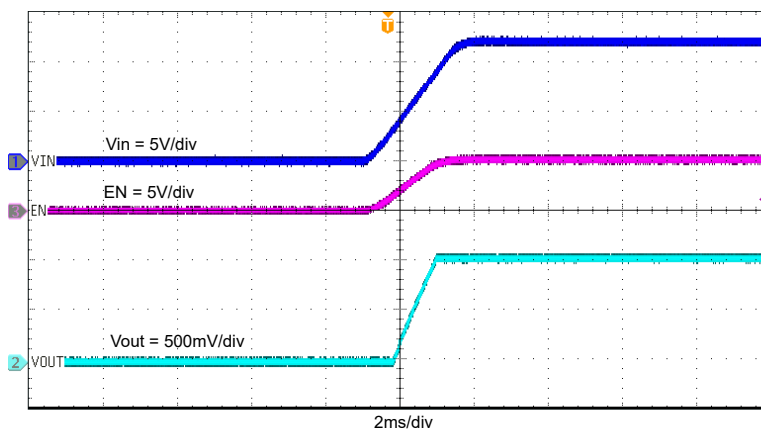
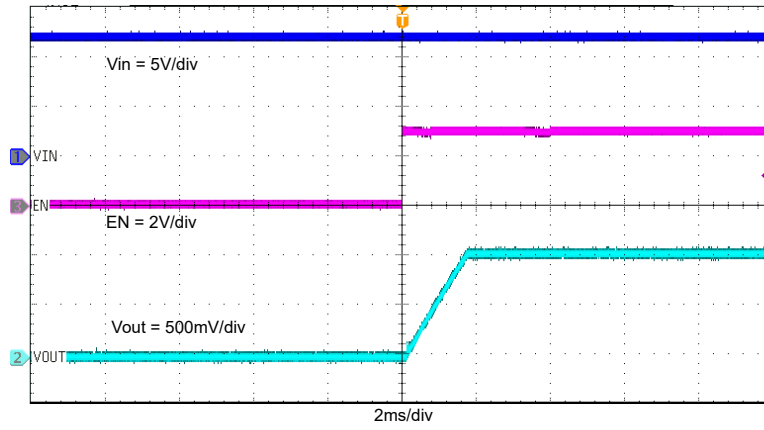


Figure 4-10. TPS563252EVM Start-Up Relative to  $V_{IN}$

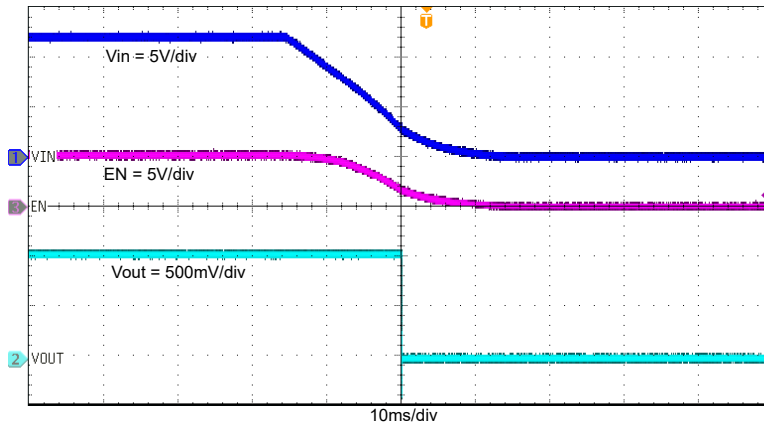




**Figure 4-11. TPS563252EVM Start-Up Relative to EN**

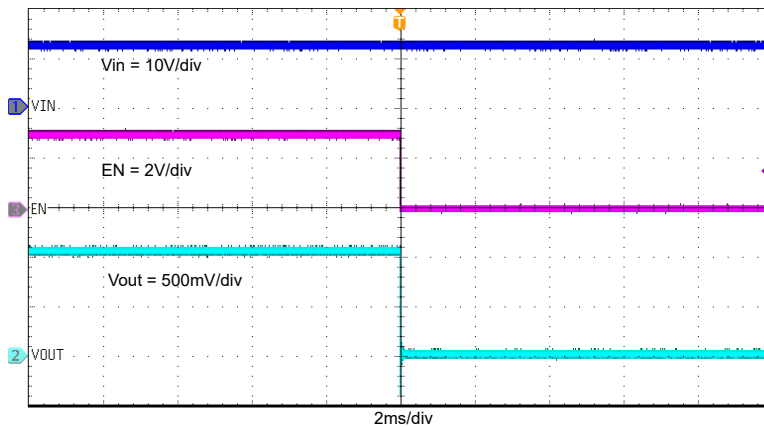

**Figure 4-12. TPS563252EVM Shutdown Relative to  $V_{IN}$**

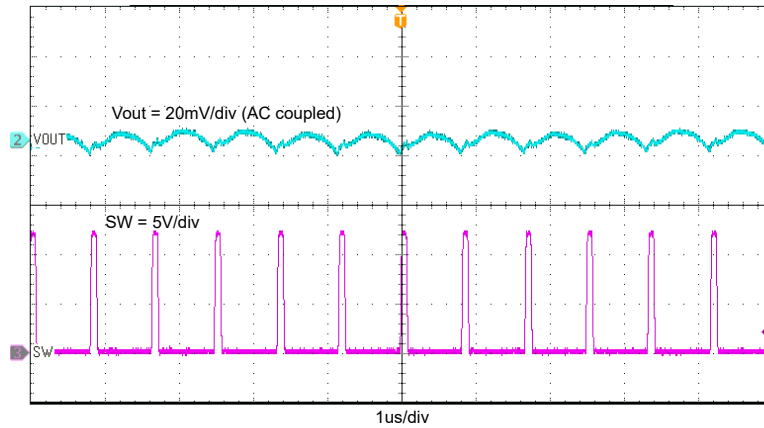

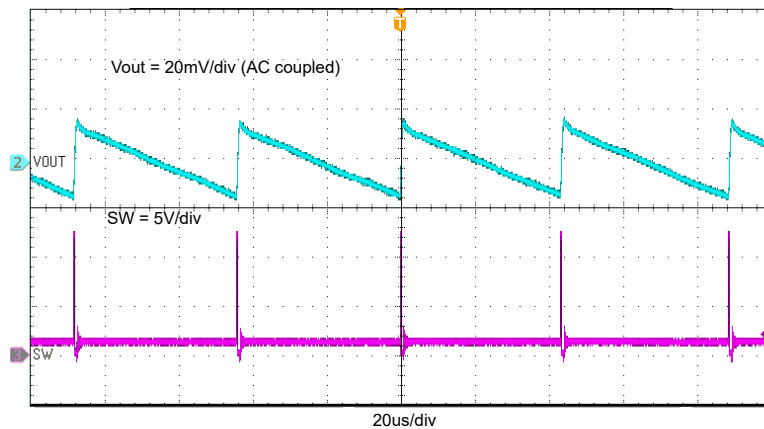
**Figure 4-13. TPS563252EVM Shutdown Relative to EN**

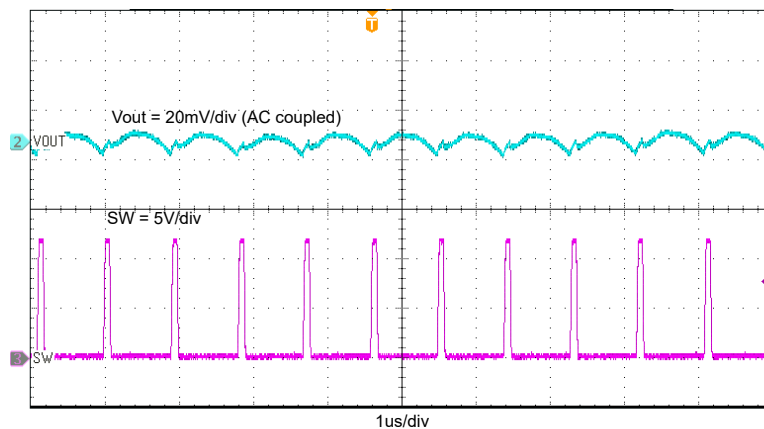

## 5 Board Layout

This section provides a description of the TPS56325xEVM, board layout, and layer illustrations.

### 5.1 Layout

Figure 5-1, Figure 5-2, and Figure 5-3 show the board layout for the TPS563252EVM. The top layer contains the main power traces for VIN, VOUT, and ground. Connections for the pins of the TPS563252 and a large area filled with ground are also on the top layer. Most of the signal traces are also located on the top side. The input decoupling capacitors C1, C2, and C3 are located as close to the IC as possible. The input and output connectors, test points, and all of the components are located on the top side. The bottom layer is a ground plane along with the signal ground copper fill and the feedback trace from the point of regulation to the top of the resistor divider network. Both the top layer and bottom layer use 2-oz copper thickness.

Figure 5-4 and Figure 5-5 are the TPS563252EVM board top view and bottom view, respectively.

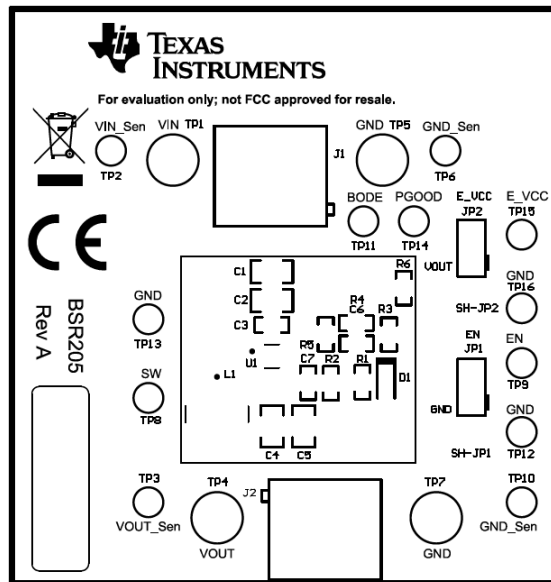


Figure 5-1. TPS563252EVM Top Assembly

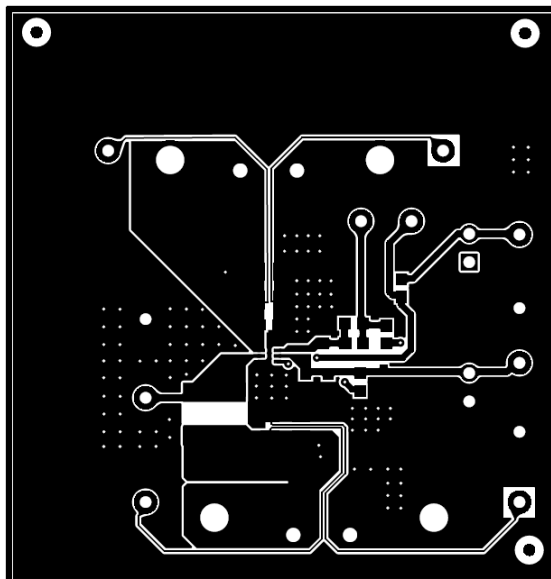


Figure 5-2. TPS563252EVM Top Layer

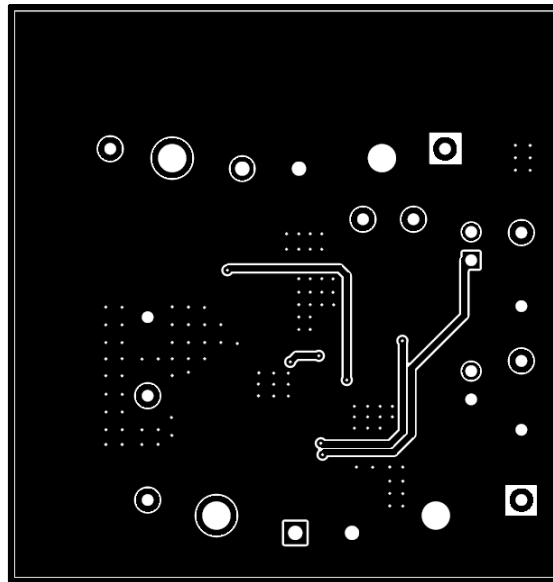


Figure 5-3. TPS563252EVM Bottom Layer

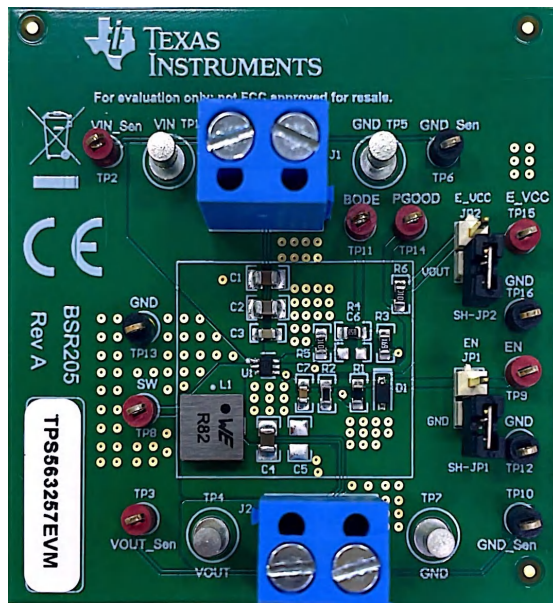


Figure 5-4. TPS563252EVM Board (Top View)

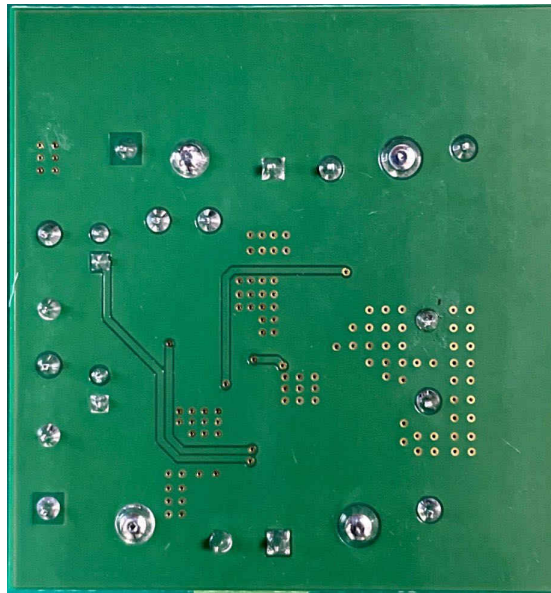


Figure 5-5. TPS563252EVM Board (Bottom View)

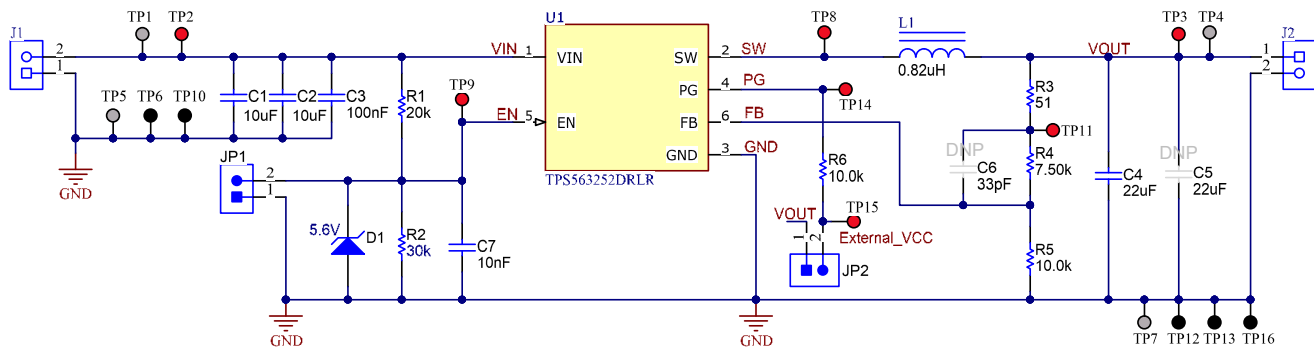


Figure 6-1. TPS563252EVM Schematic Diagram
