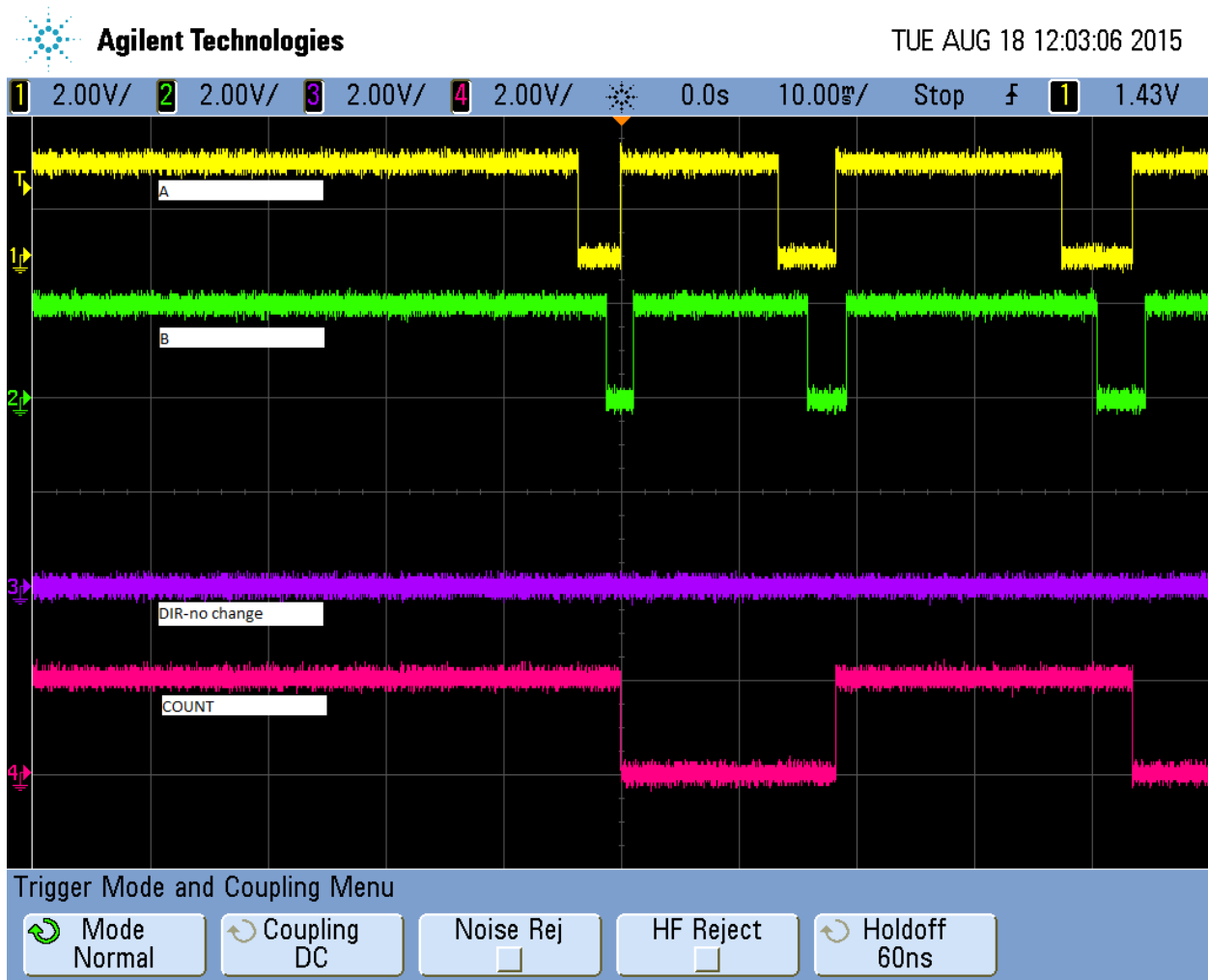


TIDA-0580, Discrete Automotive Rotary Quadrature Decoder Reference Design with I2C Interface



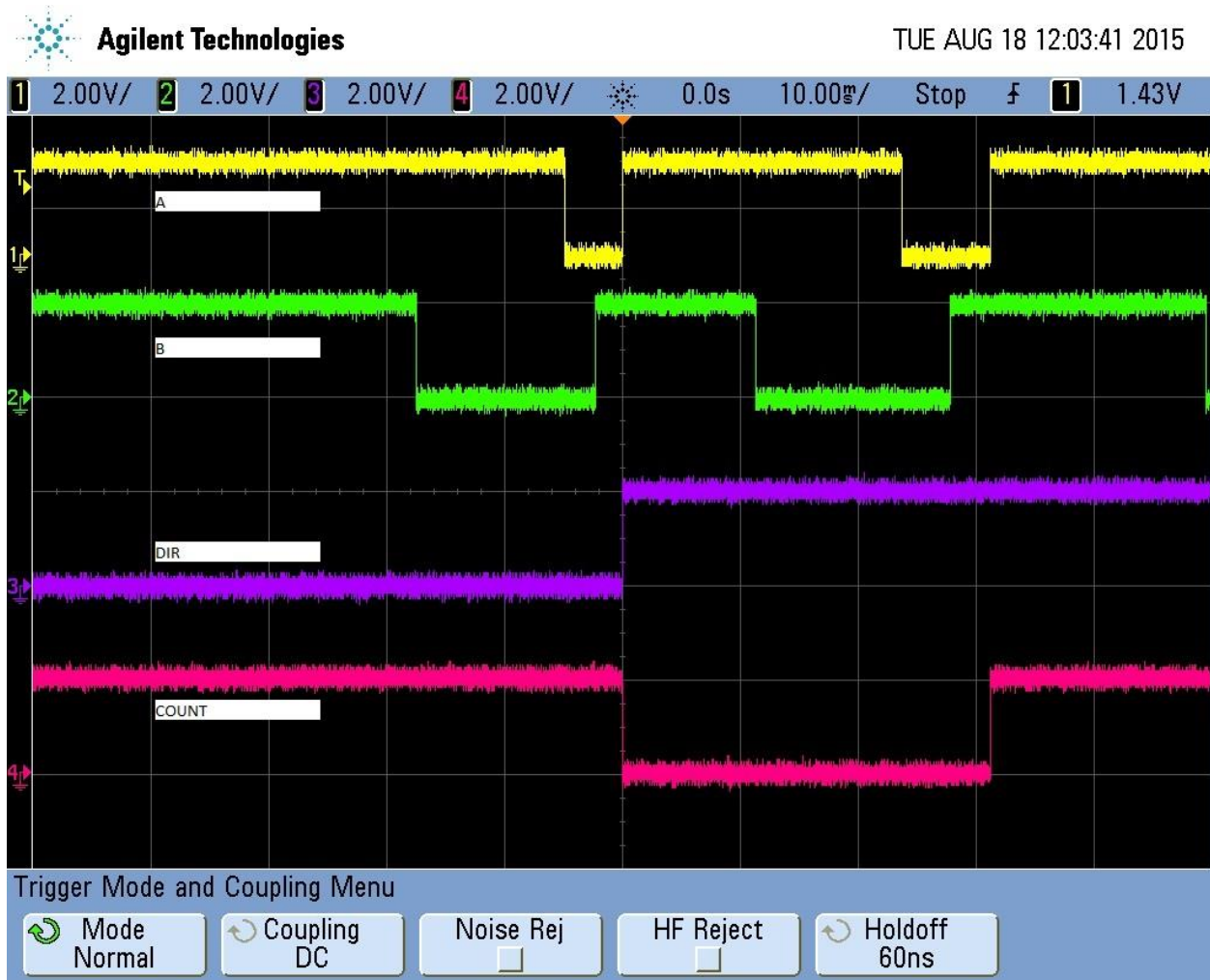
No change in direction indicated.
